Cancer Lifeline is an organization of compassionate and knowledgeable professionals who work in tandem with oncology providers and social workers to offer professional programs that help people with all types of cancer address the emotional and social stressors associated with their diagnosis and strive towards maximum health.

WHAT WE DID IN 2016:

- Offered 848 professionally facilitated support groups, classes, and presentations at 4 locations throughout King County
- Served 7,766 patients, survivors, caregivers, and employers
- Provided financial assistance grants to 630 low-income cancer patients

- Assisted 2,854 individuals with referrals and financial resource information
- Provided a listening ear and emotional support to 1,470 Lifeline callers
- Made 1,309 outreach service contacts

HOW WE MADE A DIFFERENCE:

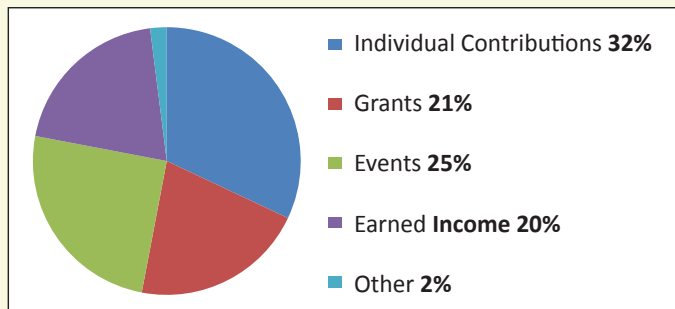
- We helped individuals experiencing cancer move towards emotional well-being

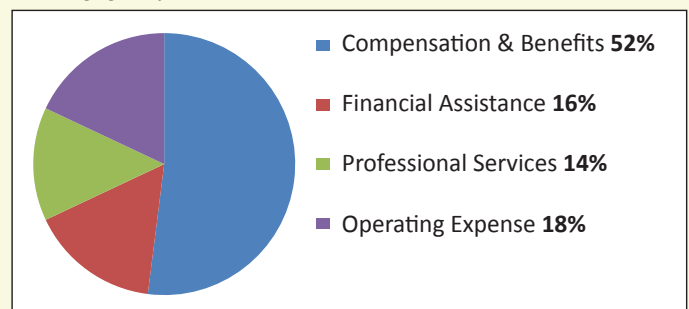
